## Solar Energy Focus 2008

On November 30, 2007, over 300 of the nation's leading national experts and regional business leaders attended this watershed conference in Annapolis, MD. There was a vibrant exchange of information on technology and policies that will assist us in becoming the next major solar energy market in our nation's drive for energy diversification, economic development, and clean energy development.

We chose Annapolis as the site of our first annual conference because earlier last year, on April 24, 2007, Governor Martin O'Malley signed into law an amendment to the Renewable Portfolio Standard (RPS) that allowed solar electric systems to participate in a meaningful capacity to help diversify the state's electric supply. A goal was laid out to have two percent of Maryland's electric supply generated from solar systems by the year 2022, and thereby move Maryland into the top ten states supporting solar energy.

The conference marked the commencement of efforts to achieve this goal. We clarified the process by which the law will be executed and cleared up the remaining definitions and ambiguities so that the solar RPS programs will be clear and concise for the home and business owners who will help achieve this objective. Maryland is setting a milestone for the region, and together we are working to extend these kinds of programs to Delaware, Virginia, and the District of Columbia with the hopes of achieving continued support for solar technologies and progressing the alternative energy economy of the Chesapeake region.

MDV-SEIA will continue to hold annual meetings and other training events as we grow and fulfill the objectives of this law, including the diversification of our energy sources, developing our economy, and creating employment opportunities to deliver clean energy

### **Environment Virginia 2008**

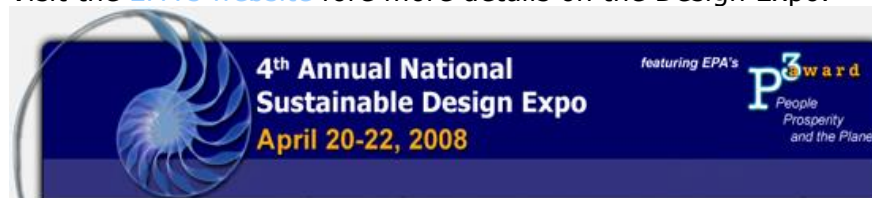

## **Panel Policy: Bills Affecting the Solar Industry**

Winter 2007/2008 Political Agenda

Current activities: MARYLAND

On January 10<sup>th</sup> the new General Assembly will be sworn in and will need to get a bill to expand the grant levels and caps. We hope to suggest \$2,500 per KW up to \$10,000 and a cap of \$20,000 for small commercial systems. As a result our primary objective will be to pass this legislation currently SB-207 and HB-377. As of yesterday, the House passed this unanimously, the Senate Budget and taxation has passed it but the Senate Finance committee has not passed it and has voted 6-5 for an unfavorable report. We need to have this bill reviewed and re-voted. We have sent out several requests to contact members of the

House Appropriations and Senate Budget and Taxation committees to not cut our budget as suggested by the Dept. of Legislative services. While we were successful in the Senate we suffered a cut from \$590,000 to \$300,000 in the House. Tawanda Gaines of PG County is Chair of that Subcommittee and needs to yield to the Senates number or reduce her cut. We will try to meet with her retain any extra unspent funds from the MD Energy Administrations Solar Energy Grant Program.

Meetings with Kevin Hughes from Governor O'Malley's offices were held on March 24<sup>th</sup> directing us to continue to lobby members of the senate Finance Committee. Senate Budget and Taxation Chairman Currie may be hesitant to bring the bill to the full floor if Chairman of Senate Finance Middleton is very opposed. Middleton cast the tie breaking vote last year for us and seems tired of supporting our issues. We need to reach him to say that this is a portion of what was missing in last years bill.

Wee are seeking a meeting with Malcolm Woolf, Director of the MD Energy Office to see what can be done to expand funding should grant funding be cut but grant amounts be increased. Current energy costs and the Governors steadfast support will awaken political interest and some movement, however the shortage of state funds to meet the basic needs of citizens is providing lots of competition for funds.

HB 1337 would help establish the Maryland Clean Energy Center (MCEC). It will be chartered as a state corporation and receive funds from private, non profit and industry groups. MCEC already has \$1million committed for the construction of an off grid building for the center from Federal funds. The center will not compete for state funds or grants. The MCEC mission is to promote clean energy markets for you to sell your products and to promote business development by supporting local clean energy businesses. MDV-SEIA hope to provide training and work collaboratively with the center.

District of Columbia:

The DC Renewable Energy Portfolio Standard is re- awakening due to the Legislation proposed by Mary Cheh to restructure how the DC Public Service Commission work and how the DC Energy Office manages the Renewable energy Demonstration project. Meetings with DC Commisioner Rick Morgan, DC Energy Office Director Jack Werner and Pepco Holdings Company Steve Sunderhauf have led to the redesigning of the grant program to become more transparent and more routine and hope fully better funded. We are seeking an additional \$300,000 to add to the Current \$150,000

Incentives will be based on system size:

- 1 – 5 kW \$4.00 / Watt
- 5 - 10 kW \$3.00 / Watt
- Greater than 10 kW, less than 20 kW \$2.50 / Watt
- Greater than 20 kW, less than 50 kW \$2.00 / Watt

There will need to be a limit on larger systems until adequate funding is available.

The New DC RPS will become more like a hybrid of the MD and NJ style bill. WE are suggesting several changes to the Cheh Bill language. The DC Board representatives, Allison Archambault and Marty Silber are involved with Colin Murchie and Exec. Director Peter Lowenthal. We have some real opportunities and need to continue to press our case for better programs that will drive sales in DC. Net metering fiasco is largely behind us now that the commission recognized the error of omission in their ruling.

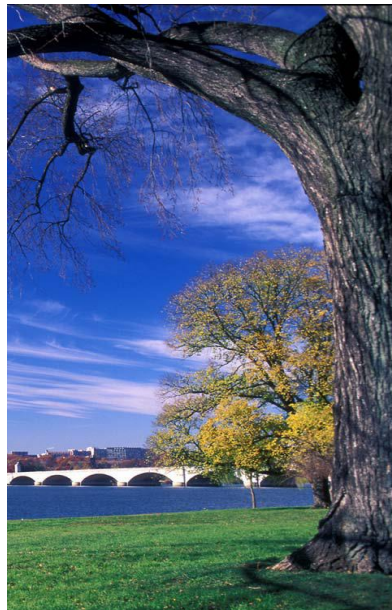

I appears that SB-320 was the one bill to survive this year in the General Assembly banning the use of restrictive covenants in new home owners associations regulations going forward.
